5. FIRE-FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

<u>Environmental Precautions</u>: Large spills, dike far ahead of liquid spill for later recovery and disposal. Prevent entry into waterways, sewers, basements or confined areas. Prevent further leakage or spillage if safe to do so.
