Prevent the spread of any spill to minimize harm to human health and the environment if safe to do so. Wear complete and proper personal protective equipment following the recommendation of Section 8 at a minimum. Dike with suitable absorbent material like granulated clay. Gather and store in a sealed container pending a waste disposal evaluation. Avoid creating dusts. Eliminate ignition sources. If a vacuum is used, ensure that the material is wetted or otherwise treated so an explosive dust atmosphere is not created within the vacuum. Avoid runoff into storm sewers and ditches that lead to waterways.
