

Ingestion	<ul style="list-style-type: none"> ■ If swallowed do NOT induce vomiting. ■ If vomiting occurs, lean patient forward or place on left side (head-down position, if possible) to maintain open airway and prevent aspiration. ■ Observe the patient carefully. ■ Never give liquid to a person showing signs of being sleepy or with reduced awareness; i.e. becoming unconscious. ■ Give water to rinse out mouth, then provide liquid slowly and as much as casualty can comfortably drink. ■ Seek medical advice.

Both dimercaptol and calcium disodium edetate are said to be effective in acute experimental tungsten poisonings.

SECTION 11 TOXICOLOGICAL INFORMATION**Information on toxicological effects**

Inhaled	The material is not thought to produce either adverse health effects or irritation of the respiratory tract following inhalation (as classified by EC Directives using animal models). Nevertheless, adverse systemic effects have been produced following exposure of animals by at least one other route and good hygiene practice requires that exposure be kept to a minimum and that suitable control measures be used in an occupational setting. Tungsten is relatively inert and produces few respiratory effects.
Ingestion	Accidental ingestion of the material may be damaging to the health of the individual. If given orally, tungsten can accumulate in the spleen, kidney and liver. Symptoms of poisoning include diarrhea, stoppage of breathing and circulatory collapse leading to death.
Skin Contact	The material is not thought to produce adverse health effects or skin irritation following contact (as classified by EC Directives using animal models). Nevertheless, good hygiene practice requires that exposure be kept to a minimum and that suitable gloves be used in an occupational setting. Open cuts, abraded or irritated skin should not be exposed to this material. Entry into the blood-stream, through, for example, cuts, abrasions or lesions, may produce systemic injury with harmful effects. Examine the skin prior to the use of the material and ensure that any external damage is suitably protected.
Eye	Although the material is not thought to be an irritant (as classified by EC Directives), direct contact with the eye may cause transient discomfort characterized by tearing or conjunctival redness (as with windburn). Slight abrasive damage may also result.
Chronic	Long-term exposure to the product is not thought to produce chronic effects adverse to the health (as classified by EC Directives using animal models); nevertheless exposure by all routes should be minimized as a matter of course. Long term exposure to high dust concentrations may cause changes in lung function i.e. pneumoconiosis; caused by particles less than 0.5 micron penetrating and remaining in the lung.

For tungsten and its compounds:

Tungsten and most tungsten compounds have low vapor pressures at 25 C and are expected to exist in the particulate form in air. Some exceptions are tungsten carbonyl, which is expected to exist in both vapor and particulate phases in the atmosphere, and tungsten hexafluoride, which exists as a gas at room temperature. Vapor- and particulate-phase tungsten compounds may be removed from the air by wet and dry deposition. Soil containing tungsten can be re-suspended into the atmosphere by wind.
